**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 24, 2021, by JPMORGAN CHASE BANK, N.A., as Administrative Agent, in favor of DART INDUSTRIES INC., a Delaware corporation (“Dart”).

W I T N E S S E T H:

WHEREAS, DART INDUSTRIES INC., a Delaware corporation (the “Grantor”), and Administrative Agent were parties to that certain Trademark Security Agreement, dated as of June 2, 2011, pursuant to which the Grantor granted a security interest to Administrative Agent in certain trademarks, including the Trademark Collateral (as defined below), as security for certain obligations owing by Grantor to Administrative Agent;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 06, 2013, at Reel 4975, Frame 0761;

WHEREAS, the Grantor has requested that Administrative Agent release its security interest in certain trademarks included in the Trademark Collateral and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of the Grantor’s right, title and interest in and to the following (collectively the “Trademark Collateral”):

(i) each trademark, trademark registration, and trademark application listed on **Schedule A** hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on **Schedule A** hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.

2. Administrative Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Administrative Agent, any and all of Administrative Agent’s right, title and interest in and to the Trademark Collateral.
