**AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

**THIS AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT** (this "**Agreement**"), dated as of December 16, 2021, is made by each of the entities listed on the signature pages hereof (each a "**Grantor**" and, collectively, the "**Grantors**"), in favor of **BYLINE BANK**, an Illinois banking corporation, as the administrative agent and collateral agent (the "**Agent**") for the lenders under that certain Credit Agreement (defined below).

**WHEREAS, AIR FLOW RESEARCH HEADS, LLC**, a Delaware limited liability company ("**Company**"), and immediately upon consummation of the SCAT Acquisition, **SCAT ENTERPRISES, LLC**, a Delaware limited liability company ("**New Borrower**"; and, together with Company, individually and collectively, the "**Borrower**"), is a borrower under that certain Revolving Credit and Term Loan Agreement dated as of the date hereof among Borrower, Parent, Intermediate Holdco and certain other Guarantors party thereto, the Lenders party thereto, and the Agent (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "**Credit Agreement**").

**WHEREAS**, the Borrowers, Intermediate Holdco and Parent are party to that certain Security Agreement of even date herewith in favor of the Agent (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "**Security Agreement**").

**NOW, THEREFORE**, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

**SECTION 1. Defined Terms.** Except as otherwise expressly defined herein, all capitalized terms used in this Agreement shall have the meanings ascribed to them in the Security Agreement and, if not defined therein, in the Credit Agreement. Any term used in the UCC and not defined in this Agreement, the Security Agreement, or the Credit Agreement shall have the meaning given to such term in the UCC.

**SECTION 2. Security Interest.** As security for the Obligations, each Grantor hereby grants to the Agent (for the benefit of the Lenders) a continuing first priority security interest in and to and a lien on all of such Grantor's right, title, and interest, whether now existing or hereafter arising or acquired, in and to its Trademarks, including but not limited to the Trademarks listed on Exhibit A attached hereto (the "**Collateral**"). Each Grantor hereby requests that the U.S. Commissioner of Patents and Trademarks record this Agreement with respect to the U.S. Trademarks listed on Exhibit A attached hereto.

**SECTION 3. Incorporation by Reference.** Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

**SECTION 4. Counterparts.** This Agreement may be executed in any number of counterparts and by the different parties hereto in separate counterparts, each of which when so

executed and delivered shall be an original, but all of which shall together constitute one and the same instrument.


SECTION 5. **Amendment and Restatement**. Grantor and Agent are entering into this Agreement to satisfy their mutual desire to amend and restate that certain Trademark Security Agreement dated as of June 28, 2021 previously entered into by Parent and Borrower, in favor of Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Original Trademark Security Agreement”). It is the intention of the parties hereto that this Agreement shall not effectuate a novation of the indebtedness, obligations and liabilities of Company to Agent and Lender under the Original Trademark Security Agreement, but merely constitute a restatement and, where applicable, a substitution of the terms governing such indebtedness, obligations and liabilities. Company hereby confirms the security interest granted by Company in favor of Agent to secure all such indebtedness, obligations and liabilities owing by Company to Agent and Lender pursuant to the Original Trademark Security Agreement (except as modified herein).
