RELEASE OF TRADEMARK SECURITY AGREEMENT

This **RELEASE OF TRADEMARK SECURITY AGREEMENT** ("**TRADEMARK RELEASE**") is made as of December 16, 2021 ("**Effective Date**") executed by Capital One, National Association (the "**Administrative Agent**"), in favor of Pharm-Olam, LLC, a Delaware limited liability company (formerly known as New Pharm-Olam, LLC) (the "**Grantor**"). Capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Trademark Security Agreement (as defined herein).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement (the "**Trademark Security Agreement**"), dated as of June 19, 2020, the Grantor granted to the Administrative Agent a continuing lien on and security interest in and to all of the Grantor's right, title and interest in the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 26, 2020 at Reel 7034, Frame 0800;

WHEREAS, the Administrative Agent wishes to terminate the Trademark Security Agreement and release and restore all right, title and interest in and to the Trademark Collateral to the Grantor and to dissolve those liens and encumbrances created by the Trademark Security Agreement in respect of the Trademark Collateral as set forth on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests or liens it has and all of its right, title and interest in, to and under the Trademark Collateral, whether now owned or hereafter created or acquired by the Grantor, and (iii) reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent's right, title and interest in and to the Trademark Collateral.

The Administrative Agent agrees to take all further actions, and provide to the Grantor all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Trademark Release. The Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record this Trademark Release.

This Trademark Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


