## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release") is granted as of December 14, 2021 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as lender and for the benefit of certain credit parties (in such capacities, the "Grantee"), in favor of BASHAS' INC., an Arizona corporation (the "Grantor").

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated as of December 28, 2011 (the "Original Grant") granting the Grantee a security interest in and lien on, among other things, certain trademarks and trademark applications referenced therein;

WHEREAS, the Original Grant was originally recorded in the Assignment Division of the United States Patent and Trademark Office ("USPTO") on December 30, 2011, at Reel 4689, Frame 0336, and re-recorded on January 3, 2012, at Reel 4689, Frame 0870 as a corrective assignment to correct the name of the conveying party;

WHEREAS, the Grantor executed and delivered a Supplemental Grant of Security Interest in United States Trademarks dated as of October 8, 2014 (the "First Supplement") granting the Grantee a security interest in and lien on, among other things, certain trademarks and trademark applications referenced therein;

WHEREAS, the First Supplement was recorded in the Assignment Division of the USPTO on October 8, 2014, at Reel 5377, Frame 0678;

WHEREAS, the Grantor executed and delivered a Supplemental Grant of Security Interest in United States Trademarks dated as of September 29, 2017 (the "Second Supplement") granting the Grantee a security interest in and lien on, among other things, certain trademarks and trademark applications referenced therein;

WHEREAS, the Second Supplement was recorded in the Assignment Division of the USPTO on February 26, 2018, at Reel 6278, Frame 0887;

WHEREAS, the Grantor executed and delivered a Supplemental Grant of Security Interest in United States Trademarks dated as of March 14, 2018 (the "Third Supplement", and together with the Original Grant, the First Supplement and the Second Supplement, collectively, the "Grant") granting the Grantee a security interest in and lien on, among other things, certain trademarks and trademark applications referenced therein;

WHEREAS, the Third Supplement was recorded in the Assignment Division of the USPTO on March 14, 2018, at Reel 6292, Frame 0131; and

WHEREAS, the Grantor has requested that the Grantee provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the trademarks and trademark applications as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

(i) releases and discharges, without any representation, warranty, recourse or undertaking by the Grantee, its liens and security interests in (A) the trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto (the "Marks"), (B) all proceeds and products of the Marks, (C) the goodwill of the businesses with which the Marks are associated, and (D) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same,


(ii) terminates the Grant in all respects and shall, upon the Grantor's reasonable request and at the Grantor's sole cost and expense, take all actions reasonably necessary to record with the USPTO or otherwise effectuate the purposes of this Termination and Release, and

(iii) authorizes the Grantor to record this Termination and Release with the Commissioner for Trademarks and any other applicable government officer.
