**RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates the Agreement, releases said security interest in and to the Patents and Trademarks, and retransfers and reassigns to the Company, without representation or warranty, all of the Agent's right, title and interest in and to the Patents and Trademarks and the goodwill associated therewith.
