**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of December 6, 2021 is made by BMO Harris Bank N.A., as agent (in such capacity, including any successors thereto, the "Agent") for the benefit of the Secured Parties.

WITNESSETH:

WHEREAS, pursuant to the Guaranty and Security Agreement, dated as of April 23, 2021 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Burton Plumbing Services, LLC, a Delaware limited liability company (the "Lead Borrower"), the other Grantors from time to time party thereto, the Lenders from time to time party thereto and Agent, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Trademark Security Agreement, dated as of September 17, 2021 (the "Trademark Security Agreement"), a lien on and security interest (collectively, the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on September 20, 2021 at Reel/Frame 7425/0478.

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral, including those trademarks listed on Schedule 1 hereto.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement or the Security Agreement, as applicable.
2. Release of Security Interest. The Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Recordation. The Agent authorizes the Grantors and their designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Trademark Grantors' expense.
