NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell and assign unto Assignee, all right, title and interest in and to the Marks and Domains, together with the goodwill of the business symbolized by the Marks and Domains, and the registration thereof, rights based in common law or the laws of the various states, countries, or jurisdictions, along with that portion of the on-going and existing business to which the Marks and Domains pertain, and all rights to damages and profits due or accrued, arising out of past infringements of said Marks and Domains, including, without limitation license royalties and proceeds of infringement suits, and the right to sue for and recover the same.


