TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 22, 2021 ("Release"), is made by Bank of America, N.A. ("Bank") in favor of Associated Foreign Exchange, Inc., a California corporation ("Pledgor").

WHEREAS, pursuant to that certain Security Agreement dated as of September 10, 2007 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Pledgor and Bank, Pledgor granted to the Bank a security interest in Pledgor's trademarks, service marks, and trade names and all good will connected with or symbolized by any of the foregoing, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, "Trademark Collateral"); and

WHEREAS, pursuant to the Security Agreement, Pledgor executed and delivered to Bank, for the benefit of the Secured Parties, the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on September 4, 2012 at Reel 4854 Frame 0550 ("Notice").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank, and Pledgor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

SECTION 2. Termination and Release. Bank, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Notice; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor's expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of California.

SECTION 4. Acknowledgement. The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Security and Pledge Agreement dated as of November 14, 2014 (as amended, modified, extended or restated from time to time) by and among the Pledgor (as Obligor thereto), Bank of America, N.A., in its capacity as Administrative Agent thereto, and others party thereto.
