## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), dated as of December 21, 2021, is made by The Governor and Company of the Bank of Ireland, in its capacity as the administrative agent (the "Agent") in favor of LEG, Inc., a Delaware corporation (the "Grantor"). Capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (defined below).

**WHEREAS**, the Grantor has granted to the Agent a security interest in and to all of the Grantor's right, title and interest in and to its Trademark Collateral (as such term is defined in the Trademark Security Agreement), including the Trademarks listed on Schedule A hereto, pursuant to that certain Trademark Security Agreement, dated as of July 25, 2019, made by the Grantor in favor of the Agent (the "Trademark Security Agreement");

**WHEREAS**, the security interest in the Trademark Collateral has been recorded at the United States Patent and Trademark Office (the "USPTO") on July 25, 2019, at Reel/Frame 6703/0046; and

**WHEREAS**, the Agent has agreed to terminate and release its security interest in the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

- (a) terminates, relinquishes, releases and discharges all liens and security interests granted to the Agent in the Trademark Collateral;
- (b) reassigns, transfers, and conveys to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademark Collateral;
- (c) terminates and cancels the Trademark Security Agreement; and
- (d) agrees that it shall, at the Grantor's sole cost and expense, execute all other documents and do all other acts in writing reasonably requested by the Grantor and reasonably necessary to relinquish, confirm, effectuate or record this Termination and hereby authorizes the Grantor or its designee to record with the USPTO this Termination.

This Termination shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
