**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of December 15, 2021, by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Collateral Agent”) in favor of **4C INSIGHTS INC.**, a Delaware corporation with an address at 1 East Wacker Drive, Suite 700, Chicago, Illinois 60601 (“Pledgor”).

WITNESSETH:

WHEREAS, the Pledgor entered into that certain Trademark Security Agreement dated July 29, 2020 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on July 30, 2020 at the United States Patent and Trademark Office at Reel 7011, Frame 0827.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Pledgor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of its Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the Trademark Collateral listed on **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, intending to be legally bound, hereby agrees as follows:

1. The Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby terminates the Trademark Security Agreement, releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgor, including the Trademark Collateral listed on **Schedule A** hereto, and assigns, transfers and conveys to Pledgor such interest in the Trademark Collateral.
2. The Collateral Agent authorizes and requests that the United States Patent and Trademark Office and any other applicable government office record this Trademark Release.
3. THIS TRADEMARK RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TRADEMARK RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (EXCEPT FOR CONFLICTS OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION).
