## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Termination and Release**”) is granted as of December 1, 2021 by **GOLDMAN SACHS BANK USA**, in its capacity as collateral agent for certain secured parties (in such capacity, the “**Agent**”), in favor of **GREEN CLOUD TECHNOLOGIES, LLC**, a South Carolina limited liability company and **BONZO, LLC**, a South Carolina limited liability company (collectively, the “**Grantors**”).

**WHEREAS**, the Grantors executed and delivered Trademark Security Agreement, dated as of October 15, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Grant**”), granting the Agent a security interest in and lien on certain trademarks and trademark applications (“**Marks**”) described therein, which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on October 15, 2018, at Reel 6456, Frame 0634;

**WHEREAS**, the Grantors have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Marks as herein provided; and

**WHEREAS**, the Grantors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Marks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantors’ right, title and interest in, to and under (i) the Marks, including without limitation those trademarks and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; and assigns, transfers and conveys to Grantors any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
