## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of December 16, 2021 (this "Release"), is made by OWL ROCK CAPITAL CORPORATION, as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Secured Parties (as defined in the Guaranty and Security Agreement) in favor of WOLVERINE BRASS, INC., a Delaware corporation, PLUMBMASTER, INC., a Delaware corporation, PROFESSIONAL PLUMBING GROUP, INC., a Delaware corporation, and SPEAKMAN COMPANY, a Delaware corporation (each a "Grantor" and collectively the "Grantors").

### WITNESSETH

WHEREAS, the Grantors, among others, and the Administrative Agent are parties to that certain Guaranty and Security Agreement, dated as of April 16, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantors executed the Trademark Security Agreement, dated as of April 16, 2018 (the "Security Agreement") and recorded with the U.S. Patent and Trademark Office on April 16, 2018 at Reel/Frame Nos. 6349/0087, 6314/0701, 6314/0683, and 6314/0691, pursuant to which the Grantors pledged, assigned and transferred to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a security interest in, all of their right, title and interest in, to and under the Trademark Collateral (as defined in the Security Agreement).

WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby **DISCHARGES, TERMINATES and RELEASES**, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Security Agreement and the Security Agreement.
