**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of December 22, 2021, by the **MASSACHUSETTS BUSINESS DEVELOPMENT CORPORATION**, a Massachusetts corporation (“Lender”) in favor of **CLIO DESIGNS INCORPORATED**, a Massachusetts corporation with an address at 85 Wells Ave., Suite 106, Newton, Massachusetts 02459 (the “Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain Trademark Security Agreement dated February 26, 2016 (the “Trademark Security Agreement”) with Lender, which was recorded in the United States Patent and Trademark Office (“USPTO”) on March 9, 2016 at Reel/Frame 5748/0296;

WHEREAS, Grantor granted to the Lender, under the terms of the Trademark Security Agreement, a first priority security interest (the “Security Interest”) in, and conditionally assigned (without transferring title) all of Grantor’s right, title and interest in and to (a) each of the trademarks, and rights and interests protectible as trademarks, which were then or thereafter owned, created, acquired or used (whether pursuant to a license or otherwise) by Grantor, in whole or in part, and all trademark rights with respect thereto throughout the world, including all proceeds thereof (including license royalties and proceeds of infringement suits), and rights to renew and extend such trademarks and trademark rights, including the trademarks and trademark registrations listed in **Schedule A**; (b) the right to register trademark claims under any state or federal trademark law or regulation of any foreign country, and to apply for, renew and extend the trademark registrations and trademark rights, the right (without obligation) to sue or bring opposition or cancellation proceedings in the name of Grantor or in the name of Lender for past, present and future infringements of the trademarks, registrations or trademark rights and all rights (but not obligations) corresponding thereto in the United States and any foreign country, and the associated goodwill; (c) all general intangibles and goodwill relating to the foregoing; and (d) all proceeds of any and all of the foregoing (including, without limitation, license royalties and proceeds of infringement suits) and, to the extent not otherwise included, all payments under insurance, or any indemnity, warranty or guaranty payable by reason of loss or damage to or otherwise with respect to any of the foregoing (collectively, the “Collateral”); and


WHEREAS, the Lender has agreed to terminate and release its Security Interest in all such Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Lender hereby (a) terminates the Trademark Security Agreement, (b) releases, terminates and discharges the Security Interest, in the Collateral, and (c) re-assigns, re-transfers and re-conveys to Grantor any right, title or interest it may have in the Collateral. The Grantor, or any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in or to the Collateral), is hereby authorized to record this Release at the USPTO.


