REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of December 22, 2021, by WESTERN ALLIANCE BANK, in its capacity as administrative agent for the Lenders and collateral agent for the Secured Parties (“*Collateral Agent*”) in favor of EVENTREBELS, LLC a Delaware limited liability company (“*Grantor*”).

RECITALS

WHEREAS, Grantor granted to Collateral Agent a security interest in its trademarks, including without limitation its trademarks described on Exhibit A (collectively, the “*Trademark Collateral*”), under a Trademark Security Agreement dated as of August 6, 2021 (as may be amended, restated, supplemented or otherwise modified, the “*Security Agreement*”), and recorded with the US Patent and Trademark Office as set forth on Exhibit A. All capitalized terms used in this Agreement and not otherwise defined herein have the meaning given in the Security Agreement.

WHEREAS, Grantor has no outstanding obligations to Collateral Agent under the terms of the Security Agreement, and Collateral Agent agrees to release its security interest in the Trademark Collateral.


AGREEMENT

Now therefore, Collateral Agent terminates, discharges, cancels, and releases its security interest in the Trademark Collateral and reassigns to Grantor, without warranty or recourse, all interest of Collateral Agent in the Trademark Collateral. The Collateral Agent hereby terminates, without representation or warranty of any kind, the Security Agreement. The Collateral Agent will take all further actions, and provide Grantor and its successors, assigns, or other legal representatives, all such cooperation and assistance reasonably requested by Grantor, at Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Reassignment and Release of Security Interest.
