RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of December 22, 2021 (this “**Release**”), is made by OWL ROCK CAPITAL CORPORATION, a Maryland corporation, as administrative agent for the Secured Parties (in such capacity and together with its successors and permitted assigns, the “**Agent**”) under that certain Second Lien Trademark Security Agreement, dated as of June 3, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”) by Alacrity Network Solutions, LLC (f/k/a Alacrity Renovation Services, LLC), a Delaware limited liability company, Nexxus Solutions Group, LLC, a Delaware limited liability company and Alacrity Solutions Group, LLC (f/k/a Worley Claims Services, LLC, a Delaware limited liability company (each a “**Grantor**” and collectively, the “**Grantors**”) in favor of the Agent. Unless otherwise defined herein, terms defined in the Trademark Security Agreement and used herein have the meaning given to them in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on June 3, 2019 at reel 6660, frame 346, each Grantor granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in all of such Grantor’s right, title and interest in or to any and all of the Trademark Collateral, including such Trademark Collateral set forth on the attached Schedule A; and

WHEREAS, the Grantor’s have requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its lien on and security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby, in each case, absolutely, unconditionally, irrevocably and forever: (a) terminate the Trademark Security Agreement, (b) release, discharge, cancel and terminate the Liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (c) release, discharge, cancel and terminate its security interest in the Trademark Collateral, and (d) release and discharge any and all rights, title and interest it has in and to the security interest granted to the Agent in the Trademark Collateral, including any and all goodwill relating to the same. The Agent, on behalf of itself and the Secured Parties, authorizes and requests that the Commissioner of Trademarks and any other applicable government officer record this Release.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
