RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Release") is made as of December 23, 2021 ("Effective Date") by JPMorgan Chase Bank, N.A. (the "Administrative Agent"), in favor of Midwest Composite Technologies, LLC, a Wisconsin limited liability company, Kemeera LLC, a California limited liability company, Incodema, LLC, a New York limited liability company and ICO Mold, LLC, a Delaware limited liability company (collectively, the "Grantors"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Collateral Agreement or the Patent and Trademark Security Agreement (as defined below), as applicable.

WHEREAS, the Grantors, Fathom Guarantor, LLC ("Holdings"), Fathom Manufacturing, LLC (the "Borrower"), the Administrative Agent and the other parties thereto entered into that certain Collateral Agreement dated as of April 30, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), which required the parties to enter into the Patent and Trademark Security Agreement;

WHEREAS, the Grantors and the Administrative Agent entered into that certain Patent and Trademark Security Agreement, dated as of April 30, 2021, which was recorded with the United States Patent and Trademark Office on May 4, 2021 at Reel 056115, Frame 0825 (the "Patent and Trademark Security Agreement"), under which the Grantors granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest (the "Security Interest") in the Patent and Trademark Collateral (as defined in the Patent and Trademark Security Agreement) listed on Schedule I attached hereto (collectively, the "Released Patent and Trademark Collateral");

WHEREAS, pursuant to the payoff letter dated as of December 23, 2021, among the Borrower, Holdings and the Administrative Agent, the Administrative Agent has agreed to take actions reasonably necessary to release and terminate any and all security interests it may have in the Released Patent and Trademark Collateral pursuant to the Loan Documents, and the Grantors hereby request a specific release of the Security Interest granted and recorded against the Released Patent and Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Patent and Trademark Security Agreement, (ii) releases any and all Security Interests or other liens, security interests, right, title and interest the Administrative Agent or any Secured Parties may have in, to or under the Released Patent and Trademark Collateral pursuant to the Patent and Trademark Security Agreement and the other Loan Documents, and terminates the license to use, license or sublicense any Article 9 Collateral consisting of Intellectual Property thereunder, and (iii) re-assigns to the Grantors, any right, title or interest the Administrative Agent or any Secured Parties may have in, to or under the Released Patent and Trademark Collateral, together with the goodwill of the business symbolized thereby, in each case pursuant to the Patent and Trademark Security Agreement and the other Loan Documents.

The execution and/or delivery of this Release and any further documents and the actions associated with the release of the Security Interest and the Released Patent and


Trademark Collateral referred to in this Release by the Administrative Agent are made without recourse to or warranty by the Administrative Agent or any Secured Party.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
