PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (ABL)

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (ABL) (this “Release”), dated as of December 23, 2021, is made by CITIBANK, N.A., as Collateral Agent (in such capacity, the “Collateral Agent”) in favor of RCPH – WILMINGTON, LLC, a Delaware limited liability company, and COMMUNITY HOSPITAL OF ANDALUSIA, LLC, a Delaware limited liability company (each a “Pledgor”, and together the “Pledgors”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Pledgors, together with the other pledgors party thereto, executed and delivered that Collateral Agreement (ABL Facility), dated as of November 16, 2018, in favor of the Collateral Agent (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Pledgors, together with the other pledgors party thereto, executed and delivered that certain Trademark Security Agreement, dated November 16, 2018 in favor of the Collateral Agent (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on November 26, 2018 at Reel/Frame 6488/0340;

WHEREAS, pursuant to the Collateral Agreement and the Trademark Security Agreement, the Pledgors, and the other pledgors party thereto, granted and pledged to the Collateral Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in the IP Collateral as security for the payment and performance, as applicable, in full of the Secured Obligations; and

WHEREAS, the IP Collateral included the Trademarks listed on Schedule A hereto (the “Released Trademark Collateral”), and Pledgors have requested that the Collateral Agent now terminate and release its Security Interest in the Released Trademark Collateral.


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby terminates and releases the Security Interest in the Released Trademark Collateral which had been granted to it by Pledgors pursuant to the Collateral Agreement and the Trademark Security Agreement, without recourse to, or representation or warranty by, the Collateral Agent. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the Security Interest held by the Collateral Agent in the IP Collateral, or any other security interest granted by Pledgors or any other pledgors to the Collateral Agent.

Each Pledgor (and any successor to such Pledgor, including any person or entity hereafter holding any right, title or interest in and to the Released Trademark Collateral of such Pledgor) is hereby authorized to record this Release with the United States Patent and Trademark Office, at the applicable Pledgor’s sole cost and expense.
