## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of December 23, 2021, (this "Release") is made by REGIONS BANK ("Lender") under the Trademark Security Agreement (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement"), between SCRUBS & BEYOND, LLC, a Delaware limited liability company (the "Company") and the Lender. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.


WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office on November 10, 2017 at Reel 6201 and Frame 0686, the Company granted to the Lender a continuing security interest in all of Company's right, title and interest in Trademarks, including those set forth on the attached Schedule I, together with the goodwill of the business symbolized by Company's Trademarks.

WHEREAS, Company has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").




NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral, and (d) reassigns, grants and conveys to Company any and all right, title and interest it has in the Released Collateral.
