TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), dated as of December 23, 2021 (the "Effective Date") is between Pop Radio LP, a Delaware limited partnership, with a principal address at 13 Roszel Road, Suite C202, Princeton, NJ 08540 ("Assignor"), and Pop Radio LLC, a Utah limited liability company, with a principal address at 13 Roszel Road, Suite C202, Princeton, NJ 08540 ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark POP RADIO and U.S. federal trademark registration for such trademark (Reg. No. 1,487,052) (the "Trademark"); and

WHEREAS, Assignor desires to assign all of its right, title and interest in and to the Trademark to Assignee and Assignee desires to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby assigns and transfers unto Assignee, its successors, heirs and assigns all right, title and interest in and to the Trademark, including without limitation, the right to any registrations thereof, the right to prosecute any applications therefor, the right to have any registrations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to any priorities based on the filing of the aforesaid applications, the right to sue for past and future infringement, and the right to the goodwill of the business symbolized thereby.

2. Further Assurances. Each party shall, upon the other party's request, execute and deliver any and all additional documents and take such actions that are reasonably necessary to further effect and perfect the transfer of rights and assumptions of liabilities and obligations set forth herein.

3. Binding Provisions. This Assignment is binding upon, and inures to the benefit of the parties hereto and their respective heirs, executors, legal representatives, successors, and assigns.

4. Governing Law. All questions concerning the construction, validity and interpretation of this Assignment and the performance of the obligations imposed by this Assignment shall be governed by the internal law, not the law of conflicts, of the State of Delaware.


