**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of December 27, 2021, by **BMO HARRIS BANK N.A.** (“Administrative Agent”) in favor of **PREMIER SPECIALTY BRANDS, LLC**, a Delaware limited liability company with an address at 2865 N. Berkeley Lake Road, NW, Suite 6, Duluth, Georgia 30096 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated December 29, 2020 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on December 29, 2020 at the United States Patent and Trademark Office at Reel 7149, Frame 0123.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in all right, title and interest of the Grantor in, to and under the Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Collateral of the Grantor, and assigns, transfers and conveys to the Grantor such interest in the Collateral.
