RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release") is made by **U.S. Bank National Association**, a national banking association of the United States, in its capacity as Collateral Agent (together with its successors and assigns in such capacity, the "**Collateral Agent**"), in favor of Rangers Baseball LLC, a limited liability company of Delaware ("**Pledgor**").

WHEREAS, pursuant to the terms and conditions of those certain Intellectual Property Security Agreements by and between Pledgor and Collateral Agent dated August 21, 2017 and June 23, 2020 (the "Security Agreements"), Pledgor granted to Collateral Agent a continuing security interest in, to and under all of the Pledgor's right, title and interest in all of the Intellectual Property, and registrations of and applications therefor (collectively, the "Intellectual Property"), including, without limitation, the trademarks and copyrights set forth on Schedule A attached hereto.

WHEREAS, the Security Agreements were entered into as collateral for that certain Guaranty Agreement, dated as of August 21, 2017, by Pledgor in favor of U.S. Bank National Association, which such Guaranty Agreement has since been terminated;

WHEREAS, the August 21, 2017 Security Agreement was recorded with the United States Patent and Trademark Office on August 25, 2017 at Reel/Frame: 6138/0599;

WHEREAS, the June 23, 2020 Security Agreement was recorded with the United States Patent and Trademark Office on June 29, 2020 at Reel/Frame: 6981/0581;

WHEREAS, the August 21, 2017 Security Agreement was recorded with the United States Copyright Office on August 28, 2017 at Document #: V9949D432;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Security Agreements, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property and hereby assigns and transfers any and all interest Collateral Agent may have in and to the Intellectual Property.

Collateral Agent represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, patent, or domain name, or registration of an application to register the foregoing, or any trade name or assumed name, other than those of the foregoing set forth on Schedule A (attached hereto), in any jurisdiction throughout the world;


Collateral Agent shall, at Pledgor's expense, take all further actions, and provide to Pledgor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of

any and all documents or other instruments), reasonably requested by Pledgor to more fully and effectively effectuate the purposes of this Release.

Collateral Agent hereby authorizes Pledgor to record this Release with the United States Patent and Trademark Office, the United States Copyright Office, and any other relevant agency throughout the world.
