RELEASE OF SECURITY INTEREST IN TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that ISRAEL DISCOUNT BANK OF NEW YORK (“*Secured Party*”), DOES HEREBY CERTIFY that (x) the continuing security interest, general lien, and collateral assignment it holds in certain trademarks of B BOYS, INC., a Delaware corporation and successor by merger to B Boys LLC (“*Grantor*”), pursuant to the Trademark Security Agreement, dated as of April 6, 2020, notice of which was recorded in the United States Patent and Trademark Office (the “*USPTO*”) on April 7, 2020 at Reel 6910, Frame 0076 (as heretofore amended, modified or supplemented, the “*Security Agreement*”), which includes the trademarks identified on Schedule A annexed hereto and made a part hereof (collectively, the “*Released Trademarks*”), and any and all other collateral relating to the Released Trademarks, including the goodwill of the business symbolized thereby, is released and discharged and all interest in such property previously assigned to Secured Party under the Security Agreement, including the continuing security interest, general lien and special power of attorney, is hereby terminated and reassigned to Grantor, without representation or warranty of any kind, nature or description, and (y) the Secured Party, without any recourse, hereby terminates and cancels the Security Agreement.

The Secured Party hereby authorizes Grantor or Grantor’s authorized representative to record or file this Release of Security Interest in Trademarks with the USPTO or any other applicable governmental office or agency. The Secured Party further agrees to execute and deliver to Grantor any and all further documents and instruments, and to do all further acts which Grantor (or its agents or designees) reasonably request (at Grantor’s sole cost and expense) to confirm this Release of Security Interest in Trademarks and Grantor’s right, title and interest in and to the Released Trademarks.

This Release of Security Interest in Trademarks shall be governed by and construed in accordance with the laws of the State of New York as applied to agreements among parties resident therein.
