RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of the December 28, 2021, by CIT BANK, N.A., in its capacity as Agent (as such term is defined in the Security Agreement (as defined below)) (in such capacity, the “Agent”) pursuant to the Security Agreement (as defined below), in favor of NEW SKINNY MIXES, LLC, a Delaware limited liability company (“Grantor”).

W I T N E S S E T H

WHEREAS, the Agent and Grantor are parties to a certain Security Agreement, dated as of August 24, 2015 (the “Security Agreement”), wherein Grantor granted the Agent a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule I attached hereto (the “Trademarks”), for the benefit of the Agent;

WHEREAS, pursuant to the provisions of the Security Agreement, a Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office on April 8, 2019, at Reel 6611 and Frame 0817;

WHEREAS, Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Trademarks; and

WHEREAS, the Agent desires to grant to Grantor a specific release of the security interest granted and recorded against each Trademark.

NOW THEREFORE, for good and valuable consideration previously tendered by Grantor, the receipt and sufficiency of which are hereby acknowledged:

1. the Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the Trademarks;
2. if and to the extent that the Agent has acquired any right, title or interest in or to any of the Trademarks, the Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Agent, any and all of the Agent’s right, title, and interest in and to the Trademarks, along with any goodwill in the Trademarks that the Agent may have acquired; and
3. the Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

This Release and the rights and obligations of the parties under this Release shall be governed by, and construed and interpreted in accordance with, the law of the State of California (without reference to its choice of law rules).


