Second Lien Release of Security Interest in Trademarks

This Second Lien Release of Security Interest in Trademarks, dated as of December 21, 2021 (this “Release”), is made by Deutsche Bank Trust Company Americas, as collateral agent (in such capacity, the “Collateral Agent”) in favor of Digital Room LLC, a California limited liability company, AMC Acquisition LLC, a Delaware limited liability company, and Logo Sportswear Inc., a Delaware corporation (each a “Grantor” and collectively the “Grantors”).

WHEREAS, by (i) that certain Second Lien Security Agreement, dated as of May 21, 2019, in favor of Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and (ii) that certain related second lien Grant of Security Interest in Trademarks, dated as of May 21, 2019, in favor of Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 25, 2019, at Reel 6653 Frame 0550, the Grantors granted to Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantors’ right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantors desire Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral of the Grantors (as defined in the Trademark Security Agreement), including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel the Trademark Security Agreement any and all of its right, title and interest in and to the Trademark Collateral of the Grantors (as defined in the Trademark Security Agreement), including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantors any and all of its rights, title and interests in the Trademark Collateral.

The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
