CONFIRMATORY ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, the Assignor has agreed to confirm the assignment so that Assignee may record the same with the United States Patent and Trademark Office, United States Copyright Office, and with other applicable offices or authorities.

NOW THEREFORE, for good and valuable consideration and in consideration of the mutual premises as set forth in the Assignment Agreement, the Assignor hereby confirms to Assignee, its successors and assigns, its prior assignment and transfer of all of the Assignor’s right, title and interest in and to all of the Trademark Rights and Domain Name Rights.

Assignor hereby authorizes and requests the United States Patent and Trademark Office, the United States Copyright Office, and all offices or authorities, including those of countries or jurisdictions foreign to the United States having appropriate authority, to issue any and all such trademark or service mark registrations or amended registrations that have been or may be granted upon any application or petition for the Trademark Rights or any additional, continuing or divisional applications thereof, or other grants of protection related to the Trademark Rights or Domain Name Rights to the Assignee or to such nominees as it may designate.




