### Release of Security Interest in Trademarks

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of July 13, 2015 (the “2015 **IP Security Agreement**”), recorded in the United States Patent and Trademark Office at reel/frame 5576/0380 and pursuant to that certain Intellectual Property Security Agreement dated as of January 24, 2020 at reel/frame 6845/0283 (the “2020 IP Security Agreement”, and together with the 2015 IP Security Agreement, the “IP Security Agreement”), The Estimating Edge LLC (“**Releasee**”) granted to Silicon Valley Bank, as Lender (“**Releasor**”), a security interest in all right, title and interest of Releasee in and to the trademarks and applications listed on Schedule A attached hereto (together with the Intellectual Property Collateral (as defined in the IP Security Agreement), the “**IP Collateral**”); and

WHEREAS, Releasor wishes to provide a document suitable for recording in the United States Patent and Trademark office for purposes of recording the release, relinquishment and discharge of its security interest in the IP Collateral.


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration:

1. Release. Releasor hereby terminates the IP Security Agreement, and releases and discharges its security interest in the IP Collateral conveyed to Releasor pursuant to the IP Security Agreement and/or any other agreement, and Releasor hereby reassigns any and all such right, title and interest that it may have in the IP Collateral to Releasee.
2. Further Assurances. Releasor further agrees to execute and deliver, at Releasee’s sole expense, to Releasee any and all further documents or instruments and do any and all further acts which Releasee (or Releasee’s agents or designees) reasonably request in order to confirm Releasee’s right, title and interest in and to the IP Collateral.
