**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of December 29, 2021, and made by **DEUTSCHE BANK TRUST COMPANY AMERICAS** (the "Grantee"), to ADDISON GROUP STAFFING SERVICES, LLC, a Delaware limited liability company ("Addison Group"), ADDISON PROFESSIONAL FINANCIAL SEARCH LLC, a Delaware limited liability company ("Addison Professional"), MONDO INTERNATIONAL, LLC, a Delaware limited liability company ("Mondo"), and DAVID M. LEWIS COMPANY, LLC, a Delaware limited liability company ("David M. Lewis", and together with Addison Group, Addison Professional and Mondo, collectively, the "Grantors" and each, a "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of April 15, 2019, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on April 15, 2019, at Reel/Frame 6618/0519;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


