## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 28th day of December, 2021, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent ("Agent"), in favor of **AMERIJET HOLDINGS, INC.**, a Florida corporation, **AMERIJET INTERNATIONAL, INC.**, a Florida corporation, **I.T.N. OF MIAMI, INC.**, a Florida corporation and **AMERIJET OCEAN TRANSPORT, INC.**, a Florida corporation (collectively, the "Grantors").

WHEREAS pursuant to that certain Trademark Security Agreement, dated as of July 15, 2016, executed by the Grantors in favor of Agent and recorded with the United States Patent and Trademark Office on July 18, 2016 at Reel/Frame 5836/0241 (the "Security Agreement"), the Companies granted, assigned, and pledged to the Agent a Security Interest (as defined in the Security Agreement) in all of each Grantor's right, title, and interest in and to the Trademark Collateral (as defined in the Security Agreement).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby terminates, discharges, and releases the Security Interest all liens and security interests granted, assigned, and pledged by each Grantor in favor of Agent in the Trademark Collateral (as defined in the Security Agreement), including those Trademarks (as defined in the Security Agreement) listed on Schedule A attached hereto. Agent hereby reassigns to each applicable Grantor all right, title, and interest in and to the Trademark Collateral of such Grantor.

The Agent authorizes and requests that the United States Patent and Trademark Office record the existence of the release hereby given.

The Agent agrees to take all further actions, and provide to any Grantor and its successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by any Grantor, at such Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

CHOICE OF LAW AND VENUE, JURY TRIAL WAIVER, AND JUDICIAL REFERENCE PROVISION. THIS RELEASE SHALL BE SUBJECT TO THE PROVISIONS REGARDING CHOICE OF LAW AND VENUE, JURY TRIAL WAIVER, AND JUDICIAL REFERENCE SET FORTH IN SECTION 25 OF THE GUARANTY AND SECURITY AGREEMENT (AS DEFINED IN THE SECURITY AGREEMENT), AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, *MUTATIS MUTANDIS*.
