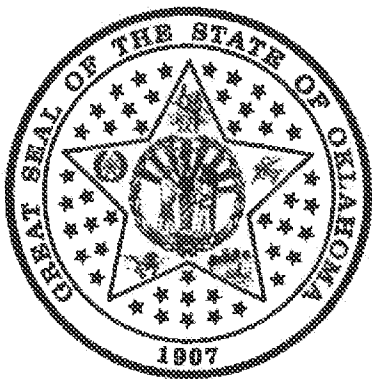

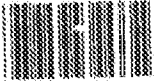

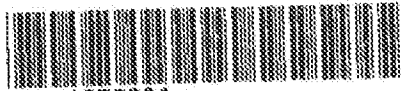

**CERTIFICATE OF CHARTER**

**True Sky Federal Credit Union**

**Oklahoma City, Oklahoma**

**Charter No. 24934**

**(Converted to Federal Charter December 17, 2021)**

Section 5 of the charter shall be amended to read as follows:

"The field of membership shall be limited to those having the following common bond:

1. Employees of the Federal Aviation Administration, Mike Monroney Aeronautical Center, who work in or are supervised from Oklahoma City, Oklahoma;
2. Members of the American Consumer Council in San Diego, California, who qualify for membership in accordance with its constitution and bylaws as of June 21, 2019;
3. Members of record of this credit union as of the December 17, 2021, date of conversion to a federal charter;

Spouses of persons who died while within the field of membership of this credit union, employees of this credit union, persons retired as pensioners or annuitants from the above employment, members of their immediate family or household, and other corporate or other legal entities in this charter."


**CERTIFICATION OF RESOLUTION OF BOARD OF DIRECTORS
