The undersigned, being duly authorized to execute and file these Articles of Conversion from a domestic corporation to a foreign limited liability company for the purposes of converting Revival Animal Health, Inc., an Iowa corporation (the "Corporation"), into a foreign limited liability company pursuant to Section 490.1113 of the Iowa Business Corporation Act, does hereby certify as follows:

1. The name of the Corporation immediately prior to filing these Articles of Conversion is Revival Animal Health, Inc.
2. Effective as of the Effective Time (as that term is defined below), the corporation shall be converted into Revival Animal Health, LLC, a Delaware limited liability company, governed under the Limited Liability Company Act of the State of Delaware.
3. The conversion shall be effective as of 12:01 a.m. on April 1, 2021 (the "Effective Time").
4. The conversion was approved as required by the Iowa Business Corporation Act.
5. The conversion was also approved as required by the Delaware Limited Liability Company Act, which is the governing statute of Revival Animal Health, LLC.
