## GRANT OF SECURITY INTEREST IN TRADEMARKS

This GRANT OF SECURITY INTEREST IN TRADEMARKS (this “**Grant of Security Interest in Trademarks**”), dated as of December 30, 2021, by COMMUNITY TAX LLC, an Illinois limited liability company (the “**Grantor**”), in favor of REPUBLIC BANK & TRUST COMPANY, a Kentucky banking corporation, as Administrative Agent under the Security Agreement referred to below (the “**Grantee**”).

### RECITALS

WHEREAS, the Grantor owns the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith, set forth on Schedule A attached hereto; and

WHEREAS, the Grantee desires to acquire a security interest in, and lien on, all of Grantor’s right, title and interest in and to Grantor’s trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith; and

WHEREAS, the Grantor is willing to grant to the Grantee a security interest in and lien on the trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith described above.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, and subject to the terms and conditions of the Security Agreement, dated as of December 30, 2021, among CTAX ACQUISITION LLC, a Delaware limited liability company (the “**Borrower**”), the Grantor, certain other Subsidiaries of the Borrower, and the Grantee (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), the Grantor hereby grants to the Grantee a security interest in, and a lien upon, all of Grantor’s right, title and interest in and to (i) the trademarks, trademark registrations, trademark applications set forth on Schedule A attached hereto, and any and all goodwill associated therewith (collectively, the “**Marks**”), together with (ii) all Proceeds (as such term is defined in the Security Agreement) of the Marks, (iii) all of the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Marks or unfair competition regarding the same (collectively, the “**Trademark Collateral**”). In no event shall Trademark Collateral include any Excluded Collateral.

This Grant of Security Interest in Trademarks is made to secure the satisfactory performance and payment of all the Obligations (as such term is defined in the Security Agreement) of the Grantor and shall be effective as of the date of the Security Agreement.

This Grant of Security Interest in Trademarks has been granted in conjunction with the security interest granted to Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest in Trademarks are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


