

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates, cancels and releases any and all security interests or liens it has against the Trademark Collateral, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and grants, assigns and conveys without recourse or warranty, to the Grantor any and all right, title and interest that Agent may have in the Trademark Collateral.
