RELEASE OF SECURITY INTEREST

Recitals

WHEREAS Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property and terminate the Security Agreement.

Now therefore, Lender agrees that it terminates and releases its security interest (i) granted in the Security Agreement, and (ii) in the Intellectual Property and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.
