NOTICE OF TERMINATION OF TRADEMARK SECURITY AGREEMENT


United States Patent and Trademark Office

Ladies and Gentlemen:

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the lien and security interest evidenced by that certain Trademark Security Agreement, dated March 31, 2020, made by **BEACON POINTE ADVISORS, LLC**, a California limited liability company (“Grantor”), having its chief executive office at 24 Corporate Plaza, Suite 150, Newport Beach, California 92660, in favor of **BARINGS FINANCE LLC**, in its capacity as administrative agent for the Lenders (“Administrative Agent”) having an office located at 300 S. Tryon Street, Suite 2500, Charlotte, North Carolina 28202 (the “Trademark Security Agreement”), which was duly recorded on March 31, 2020, at Reel/Frame 6903/0669 in the Trademark Division of the United States Patent and Trademark Office, and any other right, title or interest granted to the Administrative Agent in the Trademark Collateral (as defined in the Trademark Security Agreement), including in the trademark registrations and applications set forth on SCHEDULE I attached hereto, are hereby terminated, cancelled, discharged and released, without representation or warranty, and the Administrative Agent hereby re-transfers, re-conveys and re-assigns to the Grantor any right, title or interest it may have in or to any of the Trademark Collateral, including the trademark registrations and applications set forth on SCHEDULE I, and Administrative Agent hereby terminates the Trademark Security Agreement. The Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this release. This release shall be governed by, and construed in accordance with, the laws of the State of New York.
