**TERMINATION AND RELEASE OF  
GRANT OF A SECURITY INTEREST – TRADEMARKS**

THIS TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST – TRADEMARKS (this “Release”) is made as of December 30, 2021, by SIXTH STREET SPECIALTY LENDING, INC. (f/k/a TPG Specialty Lending, Inc.), in its capacity as administrative and collateral agent (“Agent”), in favor of VALANT MEDICAL SOLUTIONS, INC., a Washington corporation (the “Grantor”).

WHEREAS, Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in the Trademarks, including the trademarks listed in Schedule A hereto and made a part hereof. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademarks, the Agent hereby assigns, transfers and conveys to the Grantor any interest in such Trademarks.
