RELEASE OF SECURITY INTERESTS IN TRADEMARKS

December 17, 2021

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of May 28, 2021, recorded in the United States Patent and Trademark Office at Reel 007309 and Frame 0884 on May 28, 2021 (the "Trademark Security Agreement"), **ATLAS OIL COMPANY**, a Michigan corporation ("Releasee"), and the other Grantors named therein granted, collaterally assigned and pledged to **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as administrative agent (in such capacity, "Releasor"), the Security Interest in the Trademark Collateral; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Security Interests in Trademarks (this "Release") to confirm the release, relinquishment and discharge of its Security Interest in certain trademarks included in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby (i) terminates, releases, relinquishes and discharges its Security Interest in that portion of the Trademark Collateral listed on Schedule I hereto (the "Released Trademarks"), including without limitation, all of Releasee's right, title and interest in and to the Released Trademarks, and (ii) reassigns, transfers and conveys to Releasee any right, title and interest of the Releasor in the Released Trademarks, in each case, without recourse or representation or warranty, express or implied, of any kind.
3. Authorization. Releasor hereby authorizes Releasee or Releasee's designees to record this Release with the United States Patent and Trademark Office.
