RELEASE OF TRADEMARK SECURITY AGREEMENT

WHEREAS, by Security Agreement dated December 1, 2010 and the Rider to Security Agreement dated December 10, 2010 (collectively the "Security Agreement"), originally recorded on September 27, 2011 in the Trademark Assignment database of the United States Patent and Trademark Office ("USPTO") at Reel 004630 Frame 0817, Bell's Brewery, Inc., a Michigan corporation ("Grantor"), granted to PNC bank, National Association (together with its successors and assigns, in such capacity) ("Releasor"), a continuing security interest in all of Grantor's right, title and interest in trademarks, including the trademarks identified in Schedule 1 (collectively, the "Trademark Collateral"); and

WHEREAS, Releasor has agreed to release and discharge Grantor from the terms and conditions set forth in the Security Agreement, and the parties wish to record with the USPTO the release of the security interest against the trademarks.

NOW, THEREFORE, for good and valuable consideration, Releasor hereby agrees as follows:


1. Releasor hereby terminates, releases and discharges the security interest, liens, and all other rights, if any, it may have in the Trademark Collateral granted to it by Grantor pursuant to the Security Agreement.
2. Releasor hereby assigns, grants and conveys to the Grantor any and all of the Releasor's right, title, and interest in and to the Trademark Collateral.
3. Releasor agrees to execute, acknowledge, procure and deliver any and all further documents and do any and all such other acts as may be reasonably required or desirable to carry out the purposes of this Release of Trademark Security Agreement, including to effect the release of Releasor's security interest contemplated hereby.
4. Releasor hereby authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Release of Trademark Security Agreement.
5. This Release of Trademark Security Agreement and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of Michigan and shall be binding upon the parties' representatives, successors, assigns and transferees.
