**RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND  
COPYRIGHTS (ABL)**

This **RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS (ABL)** (this "ABL Release"), dated as of December 31, 2021 is made by Morgan Stanley Senior Funding, Inc., as collateral agent (in such capacity, the "Collateral Agent"), in favor of Pelican Products, Inc., Hardigg Industries, Inc., Pelican Biopharma, LLC, and Pelican BioThermal LLC (each, together with successors, a "Grantor" and collectively, the "Grantors"). All capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Patent Security Agreement, the Trademark Security Agreement or the Copyright Security Agreement, as applicable.

## RECITALS:

**WHEREAS**, Pelican Products, Inc., the Administrative Agent, the Collateral Agent, the lenders party thereto and the other parties thereto have entered into that certain ABL Credit Agreement dated as of May 1, 2018 (the "Credit Agreement"), and the Grantors, the Collateral Agent and the other parties thereto have entered into that certain Guarantee and Collateral Agreement (ABL), dated as of May 1, 2018 (the "Guarantee and Collateral Agreement");

**WHEREAS**, pursuant to the Credit Agreement and the Guarantee and Collateral Agreement, each Grantor agreed to grant to the Collateral Agent a continuing security interest in all right, title and interest of the Grantors in the Patent Collateral, including the Patents set forth on Schedule I hereto; the Trademark Collateral, including the Trademarks set forth on Schedule II hereto; and the Copyright Collateral, including the Copyrights set forth on Schedule III hereto;

**WHEREAS**, the Grantors and the Collateral Agent entered into (i) that certain Patent Security Agreement (ABL), dated as of May 1, 2018 and recorded on May 15, 2018 with the United States Patent and Trademark Office (the "USPTO") at Patent Reel 046155 Frame 0216 (the "Patent Security Agreement"); (ii) that certain Trademark Security Agreement (ABL), dated as of May 1, 2018 and recorded on May 15, 2018 with the USPTO at Trademark Reel 6385 Frame 0822 (the "Trademark Security Agreement"); and (iii) that certain Copyright Security Agreement (ABL), dated as of May 1, 2018 and recordation pending with the United States Copyright Office (the "Copyright Office") (the "Copyright Security Agreement"); and

**WHEREAS**, the Collateral Agent has agreed to terminate each of the Patent Security Agreement, Trademark Security Agreement and Copyright Security Agreement and to release its security interest in the Patent Collateral, Trademark Collateral and Copyright Collateral.

**NOW, THEREFORE**, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate each of the Patent Security Agreement, Trademark Security Agreement and Copyright Security Agreement and (b) terminate and release its security interest in the Patent Collateral, including the Patents set forth on Schedule I hereto; the Trademark Collateral, including the Trademarks set forth on Schedule II hereto; and the Copyright Collateral, including the Copyrights set forth on Schedule III hereto.


The Collateral Agent hereby authorizes the Grantors or any of their authorized representatives to file this ABL Release with the USPTO, the Copyright Office or any other


