**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is effective as of December 30, 2021, is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as administrative agent for the Lenders (as defined below) (in such capacity, together with its successors and assigns in such capacity, the “Administrative Agent”) in favor of **LAZ KARP ASSOCIATES, LLC**, a Connecticut limited liability company, as grantor, (the “Grantor”).

**WHEREAS**, the Administrative Agent and the Grantor are parties to (i) that certain Collateral Agreement dated as of October 11, 2018 by and among, *inter alia*, the Grantor, the Administrative Agent and the other persons party thereto from time to time (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time, the “Collateral Agreement”) and (ii) that certain Fourth Amended and Restated Credit Agreement dated as of June 17, 2021, by and among, *inter alia*, the Grantor, the Lenders from time to time party thereto (the “Lenders”), the Administrative Agent and the other persons party thereto from time to time (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time, the “Credit Agreement”, together with the Collateral Agreement, collectively, the “Agreements”).


**WHEREAS**, pursuant to the Agreements, the Grantor and the Administrative Agent entered into (i) that certain Trademark Security Agreement dated as of October 11, 2018, by and between the Grantor and the Administrative Agent, the Grantor granted to the Administrative Agent a security interest in the Trademarks listed on Schedule 1 attached hereto (collectively, the “2018 Trademarks”), and recorded with the United States Patent and Trademark Office on October 11, 2018 at Reel/Frame 6505/0522; and (ii) that certain Amended and Restated Trademark Security Agreement dated as of June 17, 2021, by and between the Grantor and the Administrative Agent, the Grantor granted to the Administrative Agent a security interest in the Trademark Collateral (as defined therein), including the Trademarks listed on Schedule 1 attached hereto (collectively, the “2021 Trademarks” and together with the 2018 Trademarks, collectively, the “Trademarks”), and recorded with the United States Patent and Trademark Office on June 17, 2021 at Reel/Frame 7330/0319.

**NOW, THEREFORE**, intending to be legally bound hereby and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates the Trademark Security Agreements referenced above, and releases and terminates the Administrative Agent’s security interest in, and all other rights, title and interest in and to, the Trademark Collateral, without any recourse, representation or warranty, and hereby authorizes the Grantor or Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
