

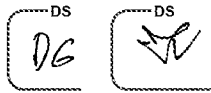


AND WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to the Trademark, together with the goodwill associated therewith;
