**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Agreement") dated as of December 10, 2021, is made by The Bank of Nova Scotia, as Administrative Agent (the "Secured Party"), in favor of Davis-Standard, LLC, a Delaware limited liability company and Thermoforming Systems, LLC, a Washington limited liability company (each a "Debtor" and collectively, the "Debtors").

**WITNESSETH:**

WHEREAS, in connection with that certain Security Agreement dated as of December 23, 2011 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the ("Security Agreement"), the Secured Party was granted a security interest in all of its right, title and interest in, to and under the Collateral (as defined in the Security Agreement) from the Debtors (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Security Agreement, as applicable);

WHEREAS, pursuant to the Security Agreement, Debtors executed and delivered that certain Trademark Collateral Agreement, dated as of December 23, 2011, and that certain Trademark Collateral Agreement dated as of November 21, 2018 (collectively, the "Trademark Collateral Agreements"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Collateral Agreement dated as of December 23, 2011 was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on December 29, 2011 at Reel/Frame 4688/0898;

WHEREAS, the Trademark Collateral Agreement dated as of November 21, 2018 was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office on November 21, 2018 at Reel/Frame 6487/0304; and

WHEREAS, the Secured Party now wishes to release its liens on, and security interests in, the Collateral in the Trademark Collateral Agreements, including, without limitation, the trademarks as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Secured Party hereby states as follows:


1. Release of Security Interest. The Secured Party hereby terminates, releases and discharges all of its security interest in the Collateral, and reassigns any and all right, title and interest that it may have in or to the Collateral to the Debtors.
2. Recordation. The Debtors or their authorized agent is authorized to record this Agreement with the USPTO.

3. Governing Law. This Agreement and the rights and obligations of the parties under this agreement shall be construed in accordance with and governed by the laws of the State of New York.

4. Further Assurances. The Secured Party shall take all further actions, and provide to the Debtors and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Debtors, and at Debtors' cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
