**TRADEMARK ASSIGNMENT AGREEMENT,
NUNC PRO TUNC**

Assignor hereby assigns to Assignee all of Assignor’s right, title and interest in and to the Trademark, including all rights therein provided by international conventions and treaties, as well as any and all rights derived from use of the Trademark, either by itself or by recorded licensees, including any and all goodwill symbolized thereby, as well as the right to sue for past, present and future infringement thereof.

2. Assignor hereby authorizes and requests the U.S. Patents and Trademark Office and any corresponding entities or agencies in any applicable foreign countries, to record Assignee as the owner of the Trademark.
