**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Agreement”) dated as of January 4, 2022, from PINNACLE BANK (the “Lender”), in favor of H.A ECKHART & ASSOCIATES, INC., a Michigan corporation (“Grantor”).

WITNESSETH:

WHEREAS, in connection with the Trademark Security Agreement, dated as of November 14, 2017 (as amended, supplemented or otherwise modified prior to the date hereof, the “Trademark Security Agreement”), the Grantor granted the Lender a security interest in all of its right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement) (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the “USPTO”) on November 17, 2017 at Reel 006208, Frame 0442; and

WHEREAS, the Lender now wishes to release its liens on, and security interests in, the Trademarks, including, without limitation, the trademarks as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Lender hereby states as follows:

1. Release of Security Interest. The Lender hereby terminates the Trademark Security Agreement and terminates, releases and discharges all of its security interest in the Trademarks, including any associated goodwill or common law rights, and reassigns any and all right, title and interest that it has in or to the Trademarks to the Grantor.
2. Recordation. The Grantor or its authorized agent is authorized to record this Agreement with the USPTO.
3. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of Tennessee.
4. Further Assurances. The Lender shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by Grantor, and at Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
