Assignor hereby assigns, transfers, sells, conveys, and delivers to Assignee, its successors and assigns, all right, title and interest in and to the Trademarks throughout the world, together with the goodwill represented and symbolized thereby, including the right to sue and recover and have damages and profits for any and all past, present or future infringements, all to be held and enjoyed by Assignee for its own use and benefit, and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made.

2. Assignor further agrees that is shall promptly, at Assignee's request, and without further consideration, execute and deliver to Assignee all documents and instruments, and take all

other actions as may be required to secure, complete or vest Assignor's right, title and interest in and to the Trademarks, or to carry out the terms of this Assignment.
