TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (this "Agreement") is made as of December 29, 2021, by and among Swapam Ghosh, DMD ("Assignor") and Spark DSO, LLC, a Pennsylvania limited liability company ("Assignee"). Assignor and Assignee are collectively referred to herein as the "Parties" and each individually as a "Party".

WHEREAS, Assignor desires to assign Assignor's entire right, title and interest in, to and under the Mark, any and all registrations and applications for registration thereof, and the goodwill of the business symbolized by the Mark to the Assignee pursuant to the terms of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor does hereby assign, transfer and set over unto Assignee, its successors, legal representatives and assigns, the Assignor's entire right, title and interest in, to and under the Mark, all registrations and applications for registration thereof, all rights derived from or associated with use of the Mark by Assignor together with the goodwill of the business symbolized by said Mark, including the right to sue for and receive all damages accruing from past, present, and future infringement of said Mark.
2. Assignor hereby covenants, warrants, and represents that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.
3. This Agreement may be executed in any number of counterparts (and by fax or pdf email), each of which will be deemed to be an original and all of which taken together will be deemed to constitute one and the same instrument.
