
CORRECTION OF IDENTIFICATION OF TYPE OF ENTITY

Carrier Corporation, a Delaware corporation, located at 13995 Pasteur Boulevard, Palm Beach Gardens, FL 33418 (“Seller”) and Carrier Commercial Refrigeration, LLC, a Delaware limited liability company located at 9300 Harris Corner Parkway, Charlotte, North Carolina 28269 (“Buyer”) were parties to that certain Trademark Assignment (“Assignment”) effective on May 26, 2005 and recorded in the records of the U.S. Patent and Trademark Office on November 9, 2006 at Reel 3425, Frame 0161.

The Assignment erroneously identified the entity type for the Buyer as a corporation, rather than a limited liability company which caused a gap in the chain of title of the trademarks.

Seller attests that the proper identification of Buyer should have been “a Delaware limited liability company.”
