Assignor authorizes and requests any official whose duty it is to issue trademarks, to issue any renewals or extensions to Assignee or its successors or assigns. Assignor authorizes the United States Patent and Trademark Office to record the

transfer of the registration for the Trademarks to Assignee as recipient of Assignor's entire right, title, and interest therein.

2. Ownership. Assignor acknowledges Assignee's exclusive right, title and interest in and to the attached listed Trademarks in Schedule A and all registrations or applications for registration thereof, and will not at any time do or cause to be done any act contesting or in way impairing or tending to impair such rights, title and interest in full exercise thereof.
