**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of December 17, 2021, by **JPMORGAN CHASE BANK, N.A.** (“Collateral Agent”) in favor of **TRANSUNION HEALTHCARE, INC.**, a Texas corporation with principal offices at 555 West Adams Street, Chicago, Illinois 60661 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated December 1, 2021 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was submitted for recording by the United States Patent and Trademark Office.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in (i) all of the Grantor’s right, title and interest in, to and under to the United States trademarks, trademark registrations and trademark applications (the “Marks”) set forth on **Schedule A** attached hereto, (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (collectively, the “Trademark Collateral”).


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all the Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to the Grantor such interest in the Trademark Collateral.
