RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of December 29, 2021 (the “Effective Date”), by **TRUIST BANK** (successor by merger to SunTrust Bank), as collateral agent (in such capacity, the “Collateral Agent”), in favor of **SALTZMAN, TANIS, PITTELL, LEVIN AND JACOBSON, LLC**, a Florida limited liability company (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below).

WHEREAS, reference is made to (a) that certain Credit Agreement, dated as of March 29, 2019 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among **PEDIATRIC ASSOCIATES HOLDING COMPANY, LLC**, a Delaware limited liability company (the “Borrower”), **PEDIATRIC ASSOCIATES INTERMEDIATE II, LLC**, a Delaware limited liability company (“Holdings”), Truist Bank, as Administrative Agent, Collateral Agent, L/C Issuer and Swing Line Lender, and the Lenders party thereto, and (b) the Security Agreement dated as of March 29, 2019 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Borrower, Holdings, the other grantors (including the Grantor) from time to time party thereto, and the Collateral Agent;

WHEREAS, pursuant to the Security Agreement, the Grantor and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of March 29, 2019, which was recorded with the United States Patent and Trademark Office on April 3, 2019 at Reel 6608, Frame 0406 (as amended, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”);

WHEREAS, pursuant to the terms of the Trademark Security Agreement, the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a continuing security interest in all of the Grantor’s right, title, and interest in and to all of its United States Trademarks (as defined in the Security Agreement), including the United States trademark applications and trademark registrations listed on Schedule I attached hereto (the “Trademark Collateral”); and

WHEREAS, the Collateral Agent now desires to release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement.
