**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

RELEASE OF SECURITY INTEREST IN TRADEMARKS (“**Release**”), effective as of March 3, 2020, given by ANTARES CAPITAL LP, a Delaware limited partnership with principal offices at 299 Park Avenue, New York, New York 10171, in its capacity as administrative agent for the benefit of the financial institutions (the “**Lenders**”) that are parties to the Credit Agreement referenced in the Security Agreement referenced below (in such capacity, the “**Administrative Agent**”), to BESTOP MORRIS, LLC, a Delaware limited liability company (“**Grantor**”), as follows:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 20, 2016 (“**Security Agreement**”), made by Grantor in favor of Administrative Agent, a security interest was granted by Grantor to Administrative Agent in the Trademark Collateral as those terms are defined in the Security Agreement, including those items listed on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on September 22, 2020, at Reel 005882, Frames 0565 through 0570; and

WHEREAS, Grantor desires Administrative Agent to release, discharge, terminate, and cancel its lien on and security interest in the Trademark Collateral set forth on Schedule A attached hereto;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantor the continuing security interest in, and any other interest Lenders may have in, Grantor’s right, title, and interest in, the Trademark Collateral set forth on Schedule A attached hereto.


The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of New York.
